4. In the Matter of Andrew Valencia for Sweetwater School Board 2016 and Andrew Valencia; FPPC No. 16/20043. Staff: Commission Counsel Theresa Gilbertson and Special Investigator Marshall Miller. Andrew Valencia was an unsuccessful candidate for the Sweetwater Union High School District Board of Trustees District 2 in the November 8, 2016 General Election. Andrew Valencia for Sweetwater School Board 2016 was his candidate-controlled committee. The Committee and Valencia failed to establish a dedicated bank account to make all expenditures from and deposit all contributions into, in violation of Government Code Section 85201 (1 count). The Committee also failed to timely file one pre-election statement for the reporting period of September 25, 2016 through October 22, 2016 and a semiannual statement for the reporting period of October 23, 2016 through December 31, 2016, in violation of Sections 84200, 84200.5 and 84200.8 (1 count). Total Proposed Penalty: \$4,500.

In the Matter of Save Avalon Now, A Committee Supporting Mayor Marshall, Council Candidates Montano and Hernandez, Opposing Council Candidates MacGugan-Cassidy, Olsen and Fertig 2016, Mike Sheehan, and Lysa Ray; FPPC No. 16/19829. Staff: Commission Counsel Christopher Burton and Special Investigator Garrett Micheels. Save Avalon Now, A Committee Supporting Mayor Marshall, Council Candidates Montano and Hernandez, Opposing Council Candidates MacGugan-Cassidy, Olsen and Fertig 2016 was primarily formed to support and oppose six different candidates for mayor and city council in the City of Avalon's April 12, 2016 Election. The principal officer of the Committee was Mike Sheehan, and the treasurer was Lysa Ray. The Committee, Sheehan, and Ray failed to timely file three 24-hour independent expenditure reports, in violation of Government Code Section 84204 (1 count); and the Committee and Sheehan failed to disclose the full name of the Committee on 14 different advertisements and include the appropriate independent expenditure disclaimer on seven different advertisements, in violation of Government Code Sections 84506 and 84506.5 (1 count). **Total Proposed Penalty: \$4,500.**

- 6. In the Matter of Ray "Coach" Curtis for Riverside County Office of Education Board 2016 and Ray Curtis; FPPC No. 16/793. Staff: Commission Counsel Theresa Gilbertson. Ray Curtis was a successful candidate for Board Member of the Riverside County Office of Education in the 2016 June 7, 2016 Primary Election. Ray "Coach" Curtis for Riverside County Office of Education Board 2016 was his candidate-controlled committee. The Committee and Curtis failed to timely file a pre-election statement for the period ending May 21, 2016, in violation of Government Code Section 84200.5 (1 count). The Committee also failed to timely file three 24-hour reports in violation of Government Code Section 84203 (1 count). Total Proposed Penalty: \$4,000.
- 7. In the Matter of Christopher Pedigo for Mayor 2016 and Christopher Pedigo; FPPC No. 16/19908 (Streamline Settlement). Staff: Commission Counsel Theresa Gilbertson, Associate Governmental Program Analyst Dominika Wojenska, and Law Clerk Savannah Weil-Dye. Christopher Pedigo was an unsuccessful candidate for Mayor of Marysville in the November 8, 2016 General Election and is a current Marysville City Councilmember. Christopher Pedigo for Mayor 2016 was his candidate-controlled committee. The Committee and Pedigo failed to timely file a pre-election campaign statement for the reporting period of January 1, 2016 through October 22, 2016, in violation of Government Code Section 84200.5 and a semiannual campaign statement for the reporting period of October 23, 2016 through December 31, 2016, in violation of Government Code Section 84200 (2 counts). Total Proposed Penalty: \$2,051.
- 8. In the Matter of Laura Santos and Santos for Mt. San Antonio College Board 2013; FPPC No. 16/274 (Streamline Settlement). Staff: Commission Counsel Theresa Gilbertson and Associate Governmental Program Analyst Dominika Wojenska. Laura Santos was a successful candidate for the Mt. San Antonio College Board of Trustees in the November 5, 2013 General Election. Santos for Mt. San Antonio College Board 2013 was her candidate controlled committee. The Committee and Santos failed to timely file four semiannual campaign statements for the reporting period of July 1, 2015 through June 30, 2017, in violation of Government Code Section 84200 (4 counts). Total Proposed Penalty: \$808.

- 9. In the Matter of Briones for School Board 2017 and Florencio Briones; FPPC No. 18/161 (Streamline Settlement). Staff: Chief of Enforcement Galena West, Political Reform Consultant Teri Rindahl, and Associate Governmental Program Analyst Dominika Wojenska. Florencio Briones was a successful candidate for the El Monte Union High School District Board of Trustees in the November 7, 2017 General Election. Briones for School Board 2017 was his candidate-controlled committee. The Committee and Briones failed to timely file a semi-annual campaign statement for the reporting period of October 22, 2017 through December 31, 2017, in violation of Government Code Section 84200 (1 count) and a 24-hour contribution report, in violation of Government Code Section 84203 (1 count). Total Proposed Penalty: \$652.
- 10. In the Matter of Committee for Advancement of Public Education Yes on Measures Y and YY and Samuel R. Biggs; FPPC No. 18/351 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chloe Hackert. The respondent is represented by Attorney Joseph A. Guardarrama of Kaufman Legal Group. The Committee for Advancement of Public Education – Yes on Measures Y and YY was a local primarily formed city committee. Samuel R. Biggs was the Committee's treasurer. The Committee and Biggs failed to timely file two semiannual campaign statements for the reporting periods of January 1, 2015 through June 30, 2015 and July 1, 2015 through July 31, 2015, in violation of Government Code Section 84200 (2 counts). Total Proposed Penalty: \$519.
- 11. In the Matter of Guerrero for Treasurer 2018 and Jack Guerrero; FPPC No. 18/620 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Jack Guerrero was an unsuccessful candidate for Los Angeles County Treasurer in the June 5, 2018 Primary Election. Guerrero for Treasurer 2018 is his candidate-controlled committee. The Committee and Guerrero failed to timely file two pre-election campaign statements for the reporting period of January 1, 2018 through April 21, 2018 and April 22, 2018 through May 19, 2018, in violation of Government Code Section 84200.5 (2 counts). Total Proposed Penalty: \$498.
- 12. In the Matter of Maria Estrada for Assembly 2018, Maria Estrada, and Stephen Metoyer; FPPC No. 18/615 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Maria Estrada was an unsuccessful candidate for Assembly in the June 5, 2018 Primary Election. Maria Estrada for Assembly 2018 is her candidate-controlled committee. Stephen Metoyer is the committee's treasurer. The Committee, Estrada and Metoyer failed to timely file two pre-election campaign statements for the reporting period of January 1, 2018 through April 21, 2018 and April 22, 2018 through May 19, 2018, in violation of Government Code Section 84200.5 (2 counts). Total Proposed Penalty: \$489.

- 13. In the Matter of Committee to Re-Elect Stacy Adler for Mono Superintendent of Schools 2018, Stacey Adler, Richard McAteer, and Cindy Podosin; FPPC No. 18/651 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Stacey Adler was a successful candidate for Mono Superintendent of Schools in the June 5, 2018 Primary Election. Committee to Re-Elect Stacy Adler for Mono Superintendent of Schools 2018 is her candidate-controlled committee. Richard McAteer and Cindy Podosin are the committee's treasurers. The Committee, Alder, McAteer and Podosin failed to timely file two pre-election campaign statements for the reporting period of January 1, 2018 through April 21, 2018, and April 22, 2018 through May 19, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$470.
- 14. In the Matter of Committee to Re-Elect Gilbert G. Otero District Attorney, Gilbert Otero, and Ivonne Peraza; FPPC No. 18/566 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Gilbert Otero was a successful candidate for Imperial County District Attorney in the June 5, 2018 Primary Election. Committee to Re-Elect Gilbert G. Otero District Attorney is his candidate-controlled committee. Ivonna Peraza is the Committee's treasurer. The Committee, Otero and Peraza failed to timely file one pre-election campaign statement for the reporting period of January 1, 2018 through April 21, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$429.
- 15. In the Matter of Carole Dorshkind, Cecily Harris, Jon Levinson, Gregory Loew, Brigid O'Farrell, Pam Salvatierra, and Mitchell Oster; FPPC No. 16/563 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Matt Nguyen for Orange County Board of Education 2018 is his candidate-controlled committee. The Committee and Nguyen failed to timely file one pre-election campaign statement for the reporting period of January 1, 2018 through April 21, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$253.

Mercado for Imperial County Auditor-Controller 2018 is his candidate-controlled committee. Edgard Garcia was the Committee's treasurer. The Committee, Mercado and Garcia failed to timely file one pre-election campaign statement for the reporting period of January 1, 2018 through April 21, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$234.
- 25. In the Matter of Vote 4 Candelore Community College 2018 and Allan Candelore; 18/415 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Intake Manager Tara Stock. Allan Candelore was an unsuccessful candidate for San Diego Community College District Trustee in the June 5, 2018 Primary Election. Vote 4 Candelore Community College 2018 is his candidate-controlled committee. The Committee and Candelore failed to timely file a pre-election campaign statement covering the reporting period of January 1, 2018 through April 21, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$223.

The Committee, Garcia and Vierra failed to timely file one pre-election campaign statement for the reporting period of April 22, 2018 through May 19, 2018, in violation of Government Code Section 84200.5 (1 count). **Total Proposed Penalty: \$218.**

The Committee, Rivera and Scharnick failed to timely file one pre-election campaign statement for the reporting period of April 22, 2018 through May 19, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$215.
- 28. In the Matter of Elect Joong Kim for County Supervisor #1 2018, Joong Kim, and Maria Juarez; FPPC No. 18/375 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chris Holm. Joong Kim was an unsuccessful candidate for Imperial County Supervisor in the June 5, 2018 Primary Election. Elect Joong Kim for County Supervisor #1 2018 is his candidate-controlled committee. Maria Juarez was the Committee's treasurer. The Committee, Kim and Juarez failed to timely file one pre-election campaign statement for the reporting period of January 1, 2018 through April 21, 2018, in violation of Government Code Section 84200.5 (1 count). Total Proposed Penalty: \$210.

Nancy D. Beavers is the Committee's treasurer. The Committee, Wheeler, and Beavers failed to timely file a pre-election statement for the period ending April 21, 2018 in violation of Government Code Section 84200.5 (1 count). The Committee also failed to timely report employer and occupation information of several contributors in violation of Government Code Section 84211, subdivision (f) (1 count). Total Proposed Penalty: \$3,500.
- 32. In the Matter of Beck for City Council 2018, Tom Beck, and Michael G. Hoover; FPPC No. 18/315 (Streamline Settlement). Staff: Chief of Enforcement Galena West and Political Reform Consultant Chloe Hackert. Tom Beck was a successful candidate for Arcadia City Councilmember in the April 10, 2018 Election.
