On February 15, 2018, the Commission adopted a Compensation and Reimbursement Policy for members of the Commission. Under the policy, any claim for compensation for preparing for meetings or hearings of the Commission which exceeds forty hours of preparation (not including Commission meeting day) in a calendar month must be approved by the Commission during a regularly-scheduled Commission meeting.

Commissioner Hatch has requested compensation for months that include more than 40 hours of time spent for preparing for meetings of the Commission. Those timesheets are attached. For the March 2017 request, 21 hours were spent studying the Commissioners' Manual and for the July 2017 request, 27 hours were spent reviewing video recordings of previous Commission meetings where relevant legislative items were discussed. Additionally, for February 2018, 12 hours were for Ad-Hoc Committee work and for March 2018, 40 hours were for Ad-Hoc Committee work.

Should the Commission approve the requested compensation, staff will process the requests accordingly.
