2	(1) The retail customers of a business entity constitute a significant segment of the public
3	generally if the business is open to the public, and provides goods or services to customers that
4	comprise a broad base of persons representative of the jurisdiction.
5	(2) Income from an individual customer is not distinguishable from the amount of income
6	received from other customers when the official is unable to recognize a significant monetary
7	difference between the business provided by the individual customer and the general clientele of
8	the business. An official is unable to recognize a significant monetary difference when:
9	(A) The business is of the type that sales to any one customer will not have a significant
10	impact on the business's annual net sales; or
11	(B) The business has no records that distinguish customers by amount of sales, and the
12	official has no other information that the customer provides significantly more income to the
13	business than an average customer.
14	(d) Government Entities. Where a government entity qualifies as a source of income as
15	defined in Section 82030, including where a public official is paid by the entity as a consultant or
16	contractor, this Regulation does not apply. However, the official may still be disqualified from
17	taking part in a governmental decision based upon the decision's financial effect on the official's
18	other economic interests, pursuant to Regulation 18703(e)(7).
