However, if a contribution or independent expenditure was not made after June 30, 2010, this statement is not required.
Aug 1, 2011 <i>Semi-Annual</i>	1/1/11 – 6/30/11	450 , 460 or 461	<ul style="list-style-type: none"> ▪ General Purpose Committees: This report is required. Use Form 460 or Form 450. ▪ Major Donor and Independent Expenditure Committees: Use Form 461. ▪ The July 31 deadline falls on Sunday, so the deadline is extended to the next business day.
Jan 31, 2012 <i>Semi-Annual</i>	7/1/11 – 12/31/11	450 , 460 or 461	<ul style="list-style-type: none"> ▪ General Purpose Committees: This report is required. Use Form 460 or Form 450. ▪ Major Donor and Independent Expenditure Committees: Use Form 461. However, if a contribution or independent expenditure was not made after June 30, 2011, this statement is not required.

Election Reports

Within 24 Hours <i>Late Reports</i>	16-day Period Before Election	496 497	<ul style="list-style-type: none"> ▪ 496: File if an independent expenditure of \$1,000 or more is made in connection with a candidate or measure being voted on in another city, county or state election in 2011. ▪ 497: File if a contribution of \$1,000 or more is made in connection with a candidate or measure being voted on in another city, county or special state election or made to a political party committee 16 days before a special state election in 2011. ▪ File by personal delivery, guaranteed overnight service, or fax.

- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Method of Delivery:** All paper filings are to be filed by personal delivery or first class mail unless otherwise noted.
- **Local or Special State Elections:** 16 days prior to an election Forms 496 and 497 must be filed if a contribution or independent expenditure of \$1,000 or more is made. Additionally, Supplemental Pre-Election Campaign Statements (Form 495) may be required for general purpose committees if contributions totaling \$10,000 or more are made in connection with an election. Major donor committees are not required to file a supplemental pre-election statement. If a city election is held in 2011, consult the filing schedule for that election for filing requirements.
- **Supplemental Independent Expenditure Reports:** File Form 465 if the committee makes independent expenditures totaling \$1,000 or more to support or oppose a candidate or a ballot measure being voted in an election in 2011.
- Local jurisdictions may impose contribution limits and additional filing requirements.
- Except for deadlines that fall on a Saturday, Sunday, or an official state holiday, filing deadlines may not be extended. Late statements are subject to a \$10 per day late fine.
- All statements are public documents.
