<b>Aug 1, 2011</b> <i>Semi-Annual</i>	thru - <b>6/30/11</b>	<a href="#">450, 460</a> or <a href="#">461</a> & possibly <a href="#">465</a>	<ul style="list-style-type: none"> <li>▪ <b>General Purpose Recipient Committees:</b> This report is required. Use Form 450 or Form 460.</li> <li>▪ <b>Major Donor and Independent Expenditure Committees:</b> Use Form 461.</li> <li>▪ <b>Form 465</b> must be filed if independent expenditures totaling \$1,000 or more are made during the late reporting period of May 22, 2011, through June 6, 2011.</li> <li>▪ The July 31 deadline falls on Saturday, so the deadline is extended to the next business day.</li> </ul>
<b>Jan 31, 2012</b> <i>Semi-Annual</i>	thru - <b>12/31/11</b>	<a href="#">450, 460</a> or <a href="#">461</a>	<ul style="list-style-type: none"> <li>▪ <b>General Purpose Recipient Committees:</b> This report is required. Use Form 460 or Form 450.</li> <li>▪ <b>Major Donor and Independent Expenditure Committees:</b> Use Form 461. However, if a contribution or independent expenditure was not made after June 30, 2011, this statement is not required.</li> </ul>

## Fair Political Practices Commission

- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement was filed.
- **Method of Delivery:** All paper filings are to be filed by personal delivery or first class mail unless otherwise noted.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due June 4 or June 5 or any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.
- **Other Election Activity:** Contributions or independent expenditures made in support of or opposition to county or state candidates, political parties and committees may trigger reporting as a county or state committee rather than as a city committee. County and State committees have different filing obligations. See [FPPC Regulation 18247.5](#) or [contact the FPPC](#) for guidance.
- Local jurisdictions may impose contribution limits and additional filing requirements.
- All statements are public documents.
