Not required for committees primarily formed to support or oppose state candidates.</li> </ul>
<b>Jan 31, 2012</b> <i>Semi-Annual</i>	thru – 12/31/11	<a href="#">460</a>	<ul style="list-style-type: none"> <li>▪ All committees must file this report.</li> </ul>
<b>Within 24 Hours</b> <i>90-Day Election Cycle Report</i>	3/7/12– 6/5/12	496 497	<ul style="list-style-type: none"> <li>▪ <b>E-Filers only:</b> <ul style="list-style-type: none"> <li>○ <b>496:</b> File if independent expenditures totaling \$1,000 or more are <i>made</i> during the period. Candidates see prohibition bullet below.</li> <li>○ <b>497:</b> Candidates file if contributions totaling \$1,000 or more are <i>received</i> from a single source during the period. Not required for committees primarily formed to support or oppose state candidates.</li> </ul> </li> </ul>
<b>Mar 22, 2012</b> <i>Pre-Election</i>	1/1/12 – 3/17/12	<a href="#">460</a>	<ul style="list-style-type: none"> <li>▪ All committees must file this report.</li> </ul>
<b>May 24, 2012</b> <i>Pre-Election</i>	3/18/12 – 5/19/12	<a href="#">460</a>	<ul style="list-style-type: none"> <li>▪ <b>All committees must file this report.</b></li> <li>▪ <b>Paper</b> copies must be filed by personal delivery or guaranteed overnight service only.</li> </ul>
<b>Within 24 Hours</b> <i>16-Day Reports</i>	5/20/12 – 6/4/12	496 497	<ul style="list-style-type: none"> <li>▪ <b>496:</b> File if independent expenditures totaling \$1,000 or more are <i>made</i>. Candidates: Do not file for expenditures made on your own committee's behalf.</li> <li>▪ <b>497:</b> File if contributions totaling \$1,000 or more are <i>received</i>.</li> <li>▪ <b>497:</b> File if contributions totaling \$1,000 or more are <i>made</i> to a political party committee or another candidate/measure committee listed on the ballot.</li> <li>▪ The recipient of a non-monetary contribution during this period must file a Form 497 within 48 hours from the time the contribution is <i>received</i>.</li> <li>▪ <b>Deadlines:</b> The deadline for a Form 497 reporting a contribution received on May 20 is May 21, and the deadline for a Form 497 due May 26, 27 or 28 is extended to May 29.</li> <li>▪ All committees must file online, including non-E-Filers.</li> </ul>
<b>Jul 31, 2012</b> <i>Semi-Annual</i>	5/20/12 – 6/30/12	<a href="#">460</a>	<ul style="list-style-type: none"> <li>▪ All committees must file this report.</li> </ul>

<b>Within 10 Business Days of the Expenditure</b> <i>\$5,000 Report</i>	Ongoing	496 497	<ul style="list-style-type: none"> <li>▪ <b>E-Filers only:</b> <ul style="list-style-type: none"> <li>○ <b>496:</b> Report each independent expenditure totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>○ <b>497:</b> Report each contribution totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>○ <b>Period:</b> List all new contributions of \$100 or more received by the committee that have not been previously reported up through the date of the \$5,000 or more payment.</li> </ul> </li> </ul>
<b>Notes:</b>			<ul style="list-style-type: none"> <li>▪ <b>Form 465:</b> Committees that make independent expenditures of \$1,000 or more must also file Form 465. The form is due on the applicable pre-election deadline, or if made during the 16 days before the election, on the semi-annual deadline.</li> <li>▪ <b>Form 511:</b> Committees that make payments of \$5,000 or more to an individual to appear in a ballot measure advertisement must file Form 511. File a paper report. E-Filers also file online.</li> <li>▪ <b>Form E-530:</b> Committees that make a payment of \$50,000 or more for an issue advocacy advertisement must file Form E-530. Online only. No paper copy required.</li> </ul>
<ul style="list-style-type: none"> <li>▪ <b>E-Filer:</b> A state committee that has received or made expenditures totaling \$25,000 or more since January 1, 2000.</li> <li>▪ <b>Forms 450, 460, 465:</b> All state committees must file paper reports. An E-Filer also files an online/electronic report.</li> <li>▪ <b>Forms 496/497:</b> All reports filed online only.</li> <li>▪ <b>Where to File:</b> State committees file reports with the Secretary of State. Only candidate controlled committees that are not E-Filers file paper copies with the Secretary of State and with the election official at the candidate's county of domicile.</li> <li>▪ <b>Filing Deadlines:</b> Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due June 2 or June 3, or to any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.</li> <li>▪ <b>Period Covered:</b> The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.</li> <li>▪ <b>Paper Filings:</b> All paper filings must be filed by personal delivery or first class mail unless otherwise noted.</li> <li>▪ <b>Contribution Limits:</b> Contributions to state candidates and to committees that make contributions to state candidates are subject to contribution limits. Refer to the contribution limit chart on the FPPC website. Some committees that feature state candidates in advertisements are also subject to contribution limits.</li> <li>▪ <b>Prohibition on Candidate Independent Expenditures:</b> A controlled committee may not make independent expenditures to support or oppose candidates and may not contribute to another committee for the purpose of making independent expenditures to support or oppose other candidates.</li> <li>▪ All statements are public documents.</li> <li>▪ For important information, refer to <a href="http://www.fppc.ca.gov">www.fppc.ca.gov</a> and click on the Candidates and Committees section.
