## **Additional Election Reports**

Depending on committee activity, the following report may also be required:

- <u>511</u>: Paid Spokesperson Report: All committees must file within 10 days of making an expenditure totaling \$5,000 or more to an individual to appear in an advertisement to support or oppose a ballot measure.
- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- Method of Delivery: All paper filings are to be filed by personal delivery or first class mail unless otherwise noted.
- Filing Deadlines: Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due June 2 or June 3, November 3 or November 4, or any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.
- Local jurisdictions may impose contribution limits and additional filing requirements.
- All statements are public documents.
