Within 24 Hours <i>16-Day Reports November 6 Election</i>	10/21/12 - 11/5/12	<u>496</u> <u>497</u>	<ul style="list-style-type: none"> ▪ 496: File if independent expenditures totaling \$1,000 or more are made. ▪ 497: File if contributions totaling \$1,000 or more are made in connection with a candidate or measure or made to a political party committee. ▪ Deadlines: All Form 496 and 497 reports must be filed within 24 hours except the deadline for a Form 497 reporting a contribution received on October 21 is October 22, and the deadline for a Form 497 due October 27 or 28 is extended to October 29. ▪ File by personal delivery, guaranteed overnight service, or fax.
Jan 31, 2013 <i>Semi-Annual</i>	1/1/12 or 7/1/12 thru - 12/31/12	<u>461</u> <u>465</u>	<ul style="list-style-type: none"> ▪ 461: File only if contributions or independent expenditures are made after June 30, 2012. ▪ 465: File if independent expenditures totaling \$1,000 or more are made between October 21 and November 5.

Additional Election Reports

Depending on committee activity, the following report may also be required:

- **511: Paid Spokesperson Report:** All committees must file within 10 days of making an expenditure totaling \$5,000 or more to an individual to appear in an advertisement to support or oppose a ballot measure.

- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Method of Delivery:** All paper filings are to be filed by personal delivery or first class mail unless otherwise noted.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due June 2 or June 3, November 3 or November 4, or any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.
- Local jurisdictions may impose contribution limits and additional filing requirements.
- All statements are public documents.
