<b>Mar 22, 2012</b> <i>Pre-Election</i>	<b>1/1/12 -</b> <b>3/17/12</b>	<a href="#">450</a> or <a href="#">460</a> & possibly <a href="#">465</a>	<ul style="list-style-type: none"> <li>▪ <b>450 or 460:</b> File if contributions or independent expenditures totaling \$500 or more are made.</li> <li>▪ <b>465:</b> File if independent expenditures totaling \$1,000 or more are made.</li> </ul>
<b>May 24, 2012</b> <i>Pre-Election</i>	<b>3/18/12 -</b> <b>5/19/12</b>	<a href="#">450</a> or <a href="#">460</a> & possibly <a href="#">465</a>	<ul style="list-style-type: none"> <li>▪ <b>450 or 460:</b> File if contributions or independent expenditures totaling \$500 or more are made.</li> <li>▪ <b>465:</b> File if independent expenditures totaling \$1,000 or more are made.</li> </ul>
<b>Within 24 Hours</b> <i>16-Day Reports</i>	<b>5/20/12 -</b> <b>6/4/12</b>	496 497	<ul style="list-style-type: none"> <li>▪ <b>496:</b> File if independent expenditures totaling \$1,000 or more are made.</li> <li>▪ <b>497:</b> File if contributions totaling \$1,000 or more are made to a political party committee or another candidate/measure committee listed on the ballot.</li> <li>▪ <b>Deadlines:</b> The deadline for a Form 497 reporting a contribution received on May 20 is May 21, and the deadline for a Form 497 due May 26, 27 or 28 is extended to May 29.</li> <li>▪ Online filing only including non-E-Filers.</li> </ul>
<b>Jul 31, 2012</b> <i>Semi-Annual</i>	<b>thru -</b> <b>6/30/12</b>	<a href="#">450</a> or <a href="#">460</a> & possibly <a href="#">465</a>	<ul style="list-style-type: none"> <li>▪ All committees must file Form 450 or Form 460.</li> <li>▪ <b>465:</b> File if independent expenditures totaling \$1,000 or more are made from May 20 through June 4.</li> </ul>

<b>Within 10 Business Days of the Expenditure</b> <i>\$5,000 Report</i>	Ongoing	496 497	<ul style="list-style-type: none"> <li>▪ <b>E-Filers only:</b> <ul style="list-style-type: none"> <li>○ <b>496:</b> Report each independent expenditure totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>○ <b>497:</b> Report each contribution totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>○ <b>Period:</b> List all new contributions of \$100 or more received by the committee that have not been previously reported up through the date of the \$5,000 or more payment.</li> </ul> </li> </ul>
<b>Within 10 Business Days of the Expenditure</b> <i>Paid Spokesperson Report</i>	Ongoing	<a href="#">511</a>	<ul style="list-style-type: none"> <li>▪ File if an expenditure totaling \$5,000 or more is made to an individual to appear in an advertisement to support or oppose a ballot measure. File a paper report. E-Filers also file online.</li> </ul>
<b>Within 48 Hours</b> <i>Issue Advocacy Report</i>	4/21/12 - 6/4/12	E-530	<ul style="list-style-type: none"> <li>▪ <b>E-Filers only:</b> File if a payment or promise of payment of \$50,000 or more is made during the 45 days prior to an election for a communication that identifies a state candidate being voted upon in the election but does not expressly advocate the election or defeat of the candidate. No paper copy required.</li> </ul>

- **E-Filer:** A state committee that made expenditures or received contributions totaling \$25,000 or more since January 1, 2000.
- **Forms 450, 460, 465:** All state committees must file paper reports. An E-Filer also files an online/electronic report.
- **Forms 496/497:** All reports filed online only.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due June 2 or June 3, or to any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.
- **Contribution Limits:** Contributions to state candidates and to committees that make contributions to state candidates are subject to contribution limits. Refer to the contribution limit chart on the FPPC website. Some committees that feature state candidates in advertisements are also subject to contribution limits. Contact local jurisdictions for information on local restrictions, if any.
- **Other Election Activity:** Contributions or independent expenditures made in support of or opposition to city or county candidates and committees may trigger reporting as a city or county committee, rather than as a state committee. See FPPC Regulation [18247.5](#) for guidance.
- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Paper Filings:** All paper filings must be filed by personal delivery or first class mail unless otherwise noted.
- All statements are public documents.
