Email only - no paper copy</li> <li>▪ <b>496:</b> File if an independent expenditure of \$1,000 or more is made in connection with a state candidate being voted on the July 23 or September 24 ballots.</li> <li>▪ <b>497:</b> File if a contribution of \$1,000 or more is made in connection with a state candidate being voted on the July 23 or September 24 ballots or made to a political party committee.</li> </ul>

<b>Jul 11, 2013</b> <i>Pre-Election July 23 Primary</i>	thru – 7/6/13	<a href="#">495</a>	<ul style="list-style-type: none"> <li>▪ Paper filing and online for E-filers.</li> <li>▪ Paper filing must be sent by personal delivery or guaranteed overnight service only.</li> <li>▪ File if contributions totaling \$10,000 or more have been made to support/oppose candidates on the July 23 ballot.</li> </ul>

<b>Sep 12, 2013</b> <i>Pre-Election</i> <i>Sep 24 General</i>	thru – 9/7/13	<a href="#">495</a>	<ul style="list-style-type: none"><li>▪ Paper filing and online for E-filers.</li><li>▪ Paper filing must be sent by personal delivery or guaranteed overnight service only.</li><li>▪ File if contributions totaling \$10,000 or more have been made to support/oppose candidates on the September 24 ballot.</li></ul>
<b>Sep 12, 2013</b> <i>IE Report</i> <i>Sep 24 General</i>	8/11/13 – 9/7/13	<a href="#">465</a>	<ul style="list-style-type: none"><li>▪ Paper filing and online for E-filers.</li><li>▪ Paper filing must be sent by personal delivery or guaranteed overnight service only.</li><li>▪ File if the committee made independent expenditures of \$1,000 or more in the period covered by the statement for a state candidate being voted on the September 24 ballot.</li></ul>
<b>Jan 31, 2014</b> <i>Semi-Annual</i>	thru – 12/31/13	<a href="#">450</a> <a href="#">460</a>	<ul style="list-style-type: none"><li>▪ Paper filing and online for E-filers.</li></ul>

- **462:** Effective January 1, 2013, a committee making an independent expenditure of \$1,000 or more must file a verification form with the FPPC. The form may be [accessed here](#).
- **E-File:** A state committee that has received or made expenditures totaling \$25,000 or more since January 1, 2000.
- **Forms 450 & 460:** All state committees must file an original and one copy in paper format by personal delivery or first class mail unless otherwise noted. An E-File also files an online/electronic report.
- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1 if no previous statement has been filed.
- **Odd Year Report:** File by April 30, 2013, if contributions totaling \$10,000 are made to committees controlled by elected state officers.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to *any* 24-hour independent expenditure reports (Form 496) or to those 24-hour contribution reports (Form 497) that are due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week. Statements filed after the deadline are subject to a \$10 per day late fine.
- **Contribution Limits:** Contributions to state candidates are subject to contribution limits of \$4,100 per election. Committees that make contributions to state candidates are subject to contribution limits. Refer to the [contribution limits chart](#) on the FPPC website. Committees making “issue ads” featuring state candidates are also subject to contribution limits.
