<b>Within 10 Business Days</b> <i>\$5,000 Report</i>	thru – 8/5/14 and 11/5/14 – 12/31/14	497	<ul style="list-style-type: none"> <li><b>E-Filers only:</b></li> <li>File if contributions totaling \$5,000 or more are <i>received</i> from a single source.</li> </ul>
<b>Within 24 Hours</b> <i>Election Cycle Reports</i>	8/6/14 – 11/4/14	497	<ul style="list-style-type: none"> <li>E-File only – no paper copy.</li> <li>File if a contribution of \$1,000 or more in the aggregate is received from a single source.</li> <li>File if a contribution of \$1,000 or more is made in the aggregate in connection with a candidate or ballot measure being voted on the November 4 ballot or to a political party committee. (Deadline closes November 3.)</li> </ul>
<b>Oct 6, 2014</b> <i>Pre-Election</i>	7/1/14 – 9/30/14	<a href="#">460</a>	<ul style="list-style-type: none"> <li>All committees must file this report.</li> <li>The October 5 deadline falls on Sunday, so the deadline is extended to the next business day.</li> </ul>
<b>Oct 23, 2014</b> <i>Pre-Election</i>	10/1/14 – 10/18/14	<a href="#">460</a>	<ul style="list-style-type: none"> <li>All committees must file this report.</li> </ul>
<b>Feb 2, 2015</b> <i>Semi-Annual</i>	10/19/14 – 12/31/14	<a href="#">460</a>	<ul style="list-style-type: none"> <li>All committees must file this report unless the committee filed termination Forms 410 and 460 before December 31, 2014.</li> <li>The January 31, 2015, deadline falls on Saturday, so the deadline is extended to the next business day.</li> </ul>

### Notes

- Committees making independent expenditures in connection with another candidate or ballot measure must file:
  - **Form 462:** A verification form must be emailed to the FPPC within 10 days of an independent expenditure of \$1,000 or more.
  - **Form 465:** This form is due on applicable pre-election/semi-annual deadlines in connection with a candidate or another ballot measure election.
  - **Form 496:** This form is due within 24 hours when made in a 90-day period of the election. Refer to the candidate or ballot measure election filing schedule.
- **Form E-530:** Committees that make a payment of \$50,000 or more for an issue advocacy advertisement must file Form E-530 *online only*, no paper copy required.

- **E-Filer:** A state committee that has received contributions or made expenditures totaling \$25,000 or more since January 1, 2000.
- **Form 460:** All state committees must file paper reports. An E-Filer also files an online/electronic report.
- **Form 496/497:** All reports filed online only. Late contributions made to other committees are filed through November 3.
- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Paper Reports:** All paper filings are filed by personal delivery or first class mail unless otherwise noted.
- **Where to File:** State committees file reports with the Secretary of State. Only candidate controlled committees that are not E-Filers file paper copies with the election official at the candidate's county of domicile.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to 24-hour independent expenditure reports (Form 496) and the deadline for the Form 497 that is due the weekend before an election. Such reports must be filed within 24 hours regardless of the day of the week. A \$10 per day late fine may be assessed on both the paper and electronic report resulting in a \$20/day fine.
- **Contribution Limits:** Refer to the [contribution limits chart](#) on the FPPC website.
