The committee may also file online, if available.</li> </ul>
April 28, 2022 1 <sup>st</sup> Pre-Election	1/1/22 - 4/23/22	450 or 460	<ul> <li>City General Purpose Committees: File if contributions or independent expenditures totaling \$500 or more are made, during the reporting period, to a city general purpose committee formed within the same jurisdiction, or to support or oppose a candidate or measure appearing on the June 7 ballot.</li> <li>County General Purpose Committees: File if contributions or independent expenditures totaling \$500 or more are made to a state or county general purpose committee, or to support or oppose a candidate or measure appearing on the June 7 state primary election ballot.</li> </ul>

## **Additional Notes:**

- \*Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- Local Ordinance: Always check on whether additional local rules apply.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-Hour/10-Day Contribution Report (Form 497) that is due the weekend before the election, and this extension never applies to any 24-Hour/10-Day Independent Expenditure Report (Form 496). Such reports must be filed within 24 hours, regardless of the day of the week.
- **Method of Delivery:** All paper filings may be filed by first class mail unless otherwise noted. A paper copy of a report may not be required if a local agency requires online filing pursuant to a local ordinance.
- **Committee Status:** A city or county committee may make contributions or independent expenditures in connection with other elections. Generally, a city committee is one that spends more than 70% of its funds in connection with elections in one city, and a county committee is one that spends more than 70% of its funds in connection with elections in one county. See FPPC Regulation 18227.5 to determine whether a committee is a city, county, or state committee.
- Form 511 Paid Spokesperson Report: File within 10 days of making either of the following expenditures related to an advertisement to support or oppose a ballot measure: 1) a payment totaling \$5,000 or more to an individual to appear in an advertisement, or 2) a payment of any amount to an individual portraying a member of a licensed occupation (e.g., nurse, doctor, firefighter).
- Multipurpose Organizations (including non-profits): A multipurpose organization that uses its general dues account to make contributions or expenditures may qualify as a major donor or independent expenditure committee and may be required to report payments on Campaign Form 461. Such an organization will qualify as a recipient committee if expenditures exceed \$50,000 in a 12-month period or \$100,000 in four consecutive calendar years. An organization that qualifies as a recipient committee may need to file reports disclosing contributors.
