This may be true even if the committee does not make a payment in connection with the particular election by virtue of receiving contributions during the applicable reporting period. This includes state elections held in both even and odd numbered years.

Additional Notes:

- *Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1 if no previous statement has been filed.
- **Deadlines: Due to the date of the February 15, AD 17 Special Primary Election, the first pre-election and the second pre-election statement for the February 15, AD 17 Special Primary Election may be combined. The filing period for a combined pre-election statement is 1/1/22 through 1/29/22. The deadline for filing a combined pre-election statement is the deadline for the 2nd pre-election, February 3, 2022.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-Hour/10-Day Contribution Report (Form 497) that is due the weekend before an election, and this extension never applies to any 24-Hour/10-Day Independent Expenditure Report (Form 496). Such reports must be filed within 24 hours regardless of the day of the week.
- California Access Replacement System (CARS): The new California Access Replacement System (CARS) is currently in development with an undetermined
 go live date. Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of
 State.
- E-filer: Until the California Access Replacement System (CARS) is live, only state committees that have received contributions or made expenditures totaling \$25,000 or more e-file. Once the CARS system is live, all state committees must file online or electronically with the Secretary of State.
- Forms 450 and 460: All state committees, including e-filers, must also file paper statements. Paper statements may be filed by first class mail unless otherwise noted. Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of State, no paper copies will be required.
- Forms 496 and 497: Payments for member communications are reportable within 24 hours if the member communication would otherwise be considered a contribution or independent expenditure, and the payments are made during the election cycle.
- State Contribution Limits: Refer to the contribution limits chart on the FPPC website.
- **Penalties:** Late statements and reports are subject to a fine of \$10 per day on both the paper and the e-filed version (e.g., \$20 per day for a late e-filed Form 460). Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of State and late e-filed statements and reports will be subject to a fine of \$10 per day. Failure to file a statement or report could result in an enforcement penalty of \$5,000 per violation.
- Public Documents: All statements and reports are public documents.
