Dear Mr. Unruh:

You have asked for advice concerning the campaign disclosure provisions of the Political Reform Act.^{1/}

QUESTION

- May the Friends of Randy Unruh Committee receive a contribution from the Friends of Jess Unruh Committee in an amount up to \$90,000?

CONCLUSION

The Act does not prohibit a candidate or committee from making contributions to or receiving contributions from another candidate or committee nor does it limit the amount of such contributions. However, you should check with the filing officer of the jurisdiction for which you are a candidate to determine if there is a local ordinance which prohibits or places limits on contributions.

FACTS

You are a candidate in an April 12, 1988 election. You are seeking a contribution from the Friends of Jess Unruh up to \$90,000.

ANALYSIS

The Act requires candidates and campaign committees to file periodic reports disclosing money raised and spent in connection with elections. (Sections 84200-84221.) The Act contains no provisions prohibiting or limiting contributions from one candidate or committee to another candidate or committee. However, some cities and counties have adopted ordinances which prohibit or limit contributions received by candidates running for offices in their jurisdictions. Therefore, you also should check with the local filing officer to determine if you may receive a \$90,000 contribution from the Friends of Jess Unruh Committee.






