I would like your assistance in providing informal advice on candidates' filing responsibilities. One of the candidates for City Council in the City of La Canada Flintridge submitted a Form 470 on March 29, 1988 to comply with the March 31, 1988 candidate's filing deadline. However, the candidate signed only his first name in the verification section. It is his contention that the form is now invalid because the signature was not complete. He also contends that because he was not notified of the deficiency in the signature within 24 hours, he should be allowed to submit a new form. My questions are: Is the form invalid. Should he be allowed to submit a new form. Should the time schedule for filing campaign reports be extended to allow him to submit a revised and/or corrected form.
