
You have requested confirmation of telephone assistance I provided to you concerning the campaign disclosure provisions of the Political Reform Act.^{1/} Because you have not provided the name of your client, we consider your request to be for informal assistance pursuant to Regulation 18329(c) (copy enclosed).^{2/}

Your letter, dated June 1, 1989, correctly summarizes my advice that ongoing independent expenditures made during the 17 days prior to an election may be estimated and disclosed on a single late independent expenditure report. This advice is based on FPPC Advice Letter A-82-201 in which we advised it was permissible to estimate late contribution reports for non-monetary contributions of an ongoing nature.

This letter will request written confirmation of oral advice you recently provided to me based on the following factual situation.


A client of this firm has made independent expenditures in connection with a municipal election to be held June 6, 1989. The filer has already complied with the requirements to file the Supplemental Independent Expenditure Reports (FPPC Form 465) with the local jurisdiction on both pre-election campaign filing deadlines. The filer will continue to make independent expenditures, which will be in excess of \$1,000, during the period between the closing date of the second pre-election campaign statement and election day (Government Code Section 82036.5) and intends to file a Late Independent Expenditure Report as required in Government Code Section 84203.

We asked whether late independent expenditures during this period could be estimated and disclosed on a single Late Independent Expenditure Report in the same manner that the Commission staff permitted estimated Late Contribution Reports for non-monetary contributions of an ongoing nature. (FPPC Informal Advice Letter A-82-201) You indicated by telephone that such Late Independent Expenditure Reports could be filed in that same fashion, and I am requesting that you confirm that advice in writing.
