Dear Mr. Donins:

You have requested advice concerning the conflict of interest provisions of the Political Reform Act ("Act").^{1/} Your request is one for general assistance. Accordingly, we are treating it as a request for informal assistance.^{2/}

QUESTIONS

Which employees of the State Compensation Insurance Fund (the "Fund") are required to file statements of economic interests? Where are those statements located, and are they of public record?

CONCLUSION

The conflict of interest code for the Fund is currently on file at the offices of the Fair Political Practices Commission. As stated in the conflict of interest code, the original financial disclosure statements for the board of directors are forwarded to our offices. However, original statements for all additional designated positions, and copies of the board of directors' statements, are filed at the Fund's offices in Sacramento. Pursuant to Section 81008, every statement of economic interests filed pursuant to the Act is a public record and open for public inspection and reproduction.

I have enclosed a copy of the conflict of interest code for the Fund. To obtain copies of statements of economic interests for designated employees, you should contact the agency directly at its Sacramento office. If you are interested only in the board of director's statements, you may contact our Technical Assistance and Analysis Division at (916) 322-5662 for assistance.

FACTS

You have been referred to the offices of the Fair Political Practices Commission to ascertain if the employees of the State Compensation Insurance Fund are filing disclosure statements, and if so, whether you can obtain copies from our office.

ANALYSIS


Conflict of interest codes must be promulgated by all state agencies. They must designate those positions within the agency which make or participate in the making of decisions which may have a foreseeable material financial effect on any financial interest. For each designated position, the code must describe the types of financial interests made reportable.

To determine which employees are designated and what disclosure requirements they have been assigned, please refer to the enclosed copy of the conflict of interest code for the Fund, complete with the appendix of designated employees and the appendix of disclosure categories.

My name is Adolph Donins, and I'm representing myself in a Workers' Compensation case. (Case No. 87 P 10301). The name of Insurance Company in the case is- State Compensation Insurance Fund, 669 County Square Drive, Ventura, Ca 93002. The private agency or company involved in this case is - DS Associates- Rehabilitation Consultants, 5755 Valentine Road, Suite 304, Ventura, Ca 93003.

My complaint is that the owners of DS Associates- Terry Dinneen, Susan Okoneski and Pamela Joyce- have spouses working for State Fund, Ventura branch in the capacity of Sales Manager and Assistant Claim Manager respectively. Therefore, in my judgment there's a violation of California Government Code & 3625. Auditors General Office, with whom I'm handling the case, suggested that I should ascertain that the State Fund has file Disclosure relating to financial interests, as far as the owners spouses of DS Associates are concerned.

When I contacted the legal department of State Fund I was told that this information is confidential, but that 'designed employees' of State Fund do file disclosure which is found with your agency - and is public record. Therefore, please write me, informing that there's disclosure done and filled with you, or, there's no disclosure.
