This is to confirm my telephone advice to you regarding the campaign disclosure provisions of the Political Reform Act (the "Act").<sup>1/</sup> This letter constitutes written advice under Section 84205.

Section 84205 states:

The Commission may by regulation or written advice permit candidates and committees to file campaign statements combining statements and reports required to be filed by this title.

A ballot measure qualification committee has submitted petitions to your office to place a measure on the November 3, 1992, ballot. The deadline for filing petitions was June 25, 1992. The campaign statement due in connection with the qualification effort (Section 84200.5(f)) would normally cover July 1, 1992, through July 9, 1992, with a filing deadline of July 16, 1992. However, we believe it is appropriate for committees primarily formed to support or oppose the qualification of the ballot measure to combine that report with the semi-annual statement for the first six months of 1992 (Section 84200). Therefore, such committees may file a single campaign statement disclosing contributions received and expenditures made during the period January 1 through July 9, 1992. The deadline for this combined report is July 16, 1992.
