Warning Letter Re: FPPC No. 11/347; Encinitas Education Committee for the Election of Gray, Martorana and McCorkle; Sharon McCorkle, Treasurer

Dear Ms. McCorkle:

The Fair Political Practices Commission (“FPPC”) enforces the provisions of the Political Reform Act (“Act”),¹ found in Government Code section 81000, et seq. This letter is in response to a referral from the San Diego County Registrar of Voters that alleged you failed to file your committee’s pre-election campaign disclosure statement.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that you failed to file semiannual campaign statements for the following period(s):

– October 17, 2010 through December 31, 2010 (Due January 31, 2011)

Section 84200.5 of the Act provides that elected officers, candidates, and committees shall file pre-election campaign statements.

Your actions violated the Act because you failed to file the aforementioned campaign statement(s) by the specified deadlines. However, since your committee does not have an enforcement history, you subsequently filed the missing statement, and you terminated your committee, we are closing your case with this warning letter. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case

proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
