Re: **Warning Letter Re: FPPC No. 11/640; Camille Kustin**

Dear Ms. Kustin:

The Fair Political Practices Commission ("FPPC") enforces the provisions of the Political Reform Act ("Act"),<sup>1</sup> found in Government Code section 81000, et seq. This letter is in response to a complaint filed against you by the Office of the Secretary of State that alleged you failed to file a quarterly lobbyist report in electronic format.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that you failed to file your quarterly lobbyist report for the October 1, 2010 through December 31, 2010 period in electronic format by the January 31, 2011 deadline.

The Act requires that lobbyists, lobbying firms, and lobbyist employers file quarterly reports of specific activity during the quarter, even if that lobbyist firm has had no activity in that quarter. (Section 86114 and 84605(d)).

Your actions violated the Act because you failed to file the lobbyist report noted above in electronic format. You must immediately file your campaign statement online or electronically with the Office of the Secretary of State. Since you appear to be inactive, we are closing our file on this matter.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable

cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.

Although the FPPC is not seeking a penalty in the current matter, you are still responsible for any late filing fees assessed by the Secretary of State's Office. (Gov. Code § 91013.)

The FPPC publishes forms and manuals to facilitate compliance with the provisions of the Act.
