Warning Letter Re: FPPC No. 15/036; Horatio Padilla, Respondent

Dear Mr. Padilla:

The Enforcement Division of the Fair Political Practices Commission (the "Commission") enforces the provisions of the Political Reform Act (the "Act")¹. This letter is in response to a referral from your filing officer that alleged you failed to file your Assuming Office Statement of Economic Interests by the March 9, 2013 deadline. The Act requires that public officials file Statements of Economic Interests (Form 700) when they assume office, annually thereafter, and within 30 days of leaving their position.

We have since learned that you left your position as a planning commissioner with the City of Maywood. You were required at that time to file a Leaving Office Statement within 30 days of leaving your position.

Your failure to file the required statements is a violation of the Act. (Gov. Code § 87204.) You must immediately file your delinquent statements with the City of Maywood. This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.


¹ The Political Reform Act is contained in Government Code sections 81000 through 91014 and all statutory references are to this code. The regulations of the Fair Political Practices Commission are contained in sections 18110 through 18997 of Title 2 of the California Code of Regulations and all regulatory references are to this source.

Although the Enforcement Division is not seeking a penalty in the current matter, you are still responsible for any late filing fees assessed by your filing officer. (Gov. Code § 91013.)

A warning letter is an Enforcement Division case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the Enforcement Division will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the Commission's website ten (10) days from the date of this letter.
