### Warning Letter Re: FPPC No. 12-269 Enhanced Capital Partners, Inc.

Dear Mr. Korengold,

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),<sup>1</sup> found in Government Code section 81000, et seq. This letter is in response to a non-filer referral from the California Secretary of State which alleged that Enhanced Capital Partners, Inc. violated the Act's lobbying reporting provisions.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that Enhanced Capital Partners, Inc. failed to timely electronically file Form 635s for the following quarters:

-July 1, 2011 through September 30, 2011

Under Section 84605, specific persons/entities are required to file electronic statements with the SOS; this includes any lobbyist, lobbying firm, or lobbyist employer that/who has exceeded thousand five hundred dollars (\$2,500) or more in a calendar quarter under any category of reportable payments, expenses, contributions, gifts, or other items. (§ 84605 (a)(4).

Your actions violated the Act because you failed to file the aforementioned report online by the specified deadlines. However, since you do not have a history of violating the Act and because the amount of lobbying activity unreported was relatively minimal, we are closing your case with this warning letter. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable

cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.

The FPPC publishes forms and manuals to facilitate compliance with the provisions of the Act.
