**Warning Letter Re: FPPC No. 09/110, Paul Gonya and Paul Gonya Committee**

Dear Mr. Gonya:

The Fair Political Practices Commission (“FPPC”) enforces the provisions of the Political Reform Act (“Act”),<sup>1</sup> found in Government Code section 81000, et seq. This letter is in response to a referral from your filing officer that alleged you failed to file multiple semi-annual campaign statements (Form 460). We have decided to close this case with a warning letter.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that you failed to file nine semi-annual campaign statements by their respective deadlines following the 2004 election. The Act requires candidates and committees to continue filing campaign statements until such time as the committee is properly terminated. Our investigation concluded that you terminated your committee with the Secretary of State on February 2, 2010, and that this termination was received by the San Diego County Registrar of Voters on February 22, 2010.

Your failure to file the required statements is a violation of the Act. (Section 87300.) This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

You must immediately file a final Form 460 with the County of San Diego detailing the disposition of any campaign funds remaining in your committee at the time of termination. This form can be found at our website, [www.fppc.ca.gov](http://www.fppc.ca.gov).

Although the Enforcement Division is not seeking a penalty in the current matter, you are still responsible for any late filing fees which may be assessed by your filing officer. (Section 91013.)

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
