**RE: Advisory Letter** ✓  
**FPPC No. 11-225; Sanger Unified School District, Marcus Johnson, Rich Smith,  
and Peter R. Filippi**

Dear Mr. Tunick:

The Fair Political Practices Commission ("Commission") enforces the provisions of the Political Reform Act (the "Act"),<sup>1</sup> found in Government Code Section 81000, and following. The Commission has concluded its investigation into allegations that your client Sanger Unified School District ("District") failed to report contributions to Peter R. Filippi's 2010 campaign for the District's Board of Trustees, in violation of Section 84211 of the Act, and that your client Peter R. Filippi failed to report those contributions from the District, in violation of Section 84211 of the Act.

Our investigation revealed that the District's Superintendent and Deputy Superintendent, Marcus Johnson and Rich Smith, respectively, used District resources, including District computers, the District's email, and compensated District time, to conduct non-District business activities, including working on Mr. Filippi's campaign. On September 2, 2010, Superintendent Johnson and Deputy Superintendent Smith sent and received emails regarding Mr. Filippi's campaign fundraising efforts during District hours, using the District's computer and email system. On September 8, 2010, September 9, 2010, September 10, 2010, and again on September 15, 2010, Deputy Superintendent Smith emailed campaign materials to Mr. Filippi's campaign during District hours, using the District's computer and email system.

As explained below, an employee must spend more than 10 percent of his or her compensated time in a single month rendering political services to a campaign for the

compensated time to be considered a contribution from the employer to the campaign. There is insufficient evidence that Superintendent Johnson and Deputy Superintendent Smith's conduct met the threshold required to be considered a contribution from the District to Mr. Filippi's campaign. As a result, we are closing this case with this Advisory Letter.

However, we are referring our case file to the California Attorney General's Office and the Fresno County District Attorney's Office to determine if any other laws were violated.

Your clients should be aware that the Act requires that every person, including a state or local agency, that makes \$10,000 or more in political contributions in a calendar year file campaign statements. (Section 84211.) Payment of salary by an employer to an employee who spends more than 10% of his or her compensated time in a single month rendering services for political purposes is considered a contribution or expenditure by the employer if the employee renders services at the request or direction of the employer. (Regulation 18423.) Rendering services for political purposes includes, but is not limited to, developing, writing, or distributing campaign literature or making arrangements for campaign literature. (Regulation 18420, subd. (b).) Additionally, contributions received from a state or local agency must be reported. (Section 84211.)

The Commission publishes forms and manuals to facilitate compliance with the provisions of the Act and provides guidance regarding obligations over the telephone and through written advice.
