**Warning Letter Re: FPPC No. 11/611, Fallbrook Firefighters Legislative Action Group;  
Eddie Jones, Treasurer**

Dear Mr. Jones:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),<sup>1</sup> found in Government Code section 81000, et seq. The Act requires campaign committees to file campaign statements at periodic intervals. This letter is in response to referrals from the San Diego County Registrar of Voters that alleged that you and your committee, the Fallbrook Firefighters Legislative Action Group, failed to file your semiannual campaign disclosure statements.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that you failed to file semiannual campaign statements for the following periods:

- July 1, 2009 through December 31, 2009
- January 1, 2010 through June 30, 2010
- July 1, 2010 through December 31, 2010

Section 84200 of the Act provides that elected officers, candidates, and committees shall file semiannual campaign statements. In addition to the campaign statements required by Section 84200, elected officers, candidates, and committees shall file pre-election statements as specified in Section 84200.5 by the deadlines set down in Section 84200.7.

Your actions violated the Act because you failed to file the aforementioned campaign statements by the specified deadlines. However, since your committee was administratively terminated by the California Secretary of State on October 10, 2010, your committee appears to no longer be active, and you have no previous enforcement history, we are closing your case with this warning letter. The information in this matter will be retained and may be considered

should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

Although the FPPC is not seeking a penalty in the current matter, and your filing obligation has been terminated, you are still required to immediately file any remaining outstanding statements for the period before the termination with the California Secretary of State. You will be responsible for any late filing fees assessed by your filing officer. (§ 91013.) If you wish to keep your committee open, you must immediately file all outstanding semiannual campaign statements with the San Diego County Registrar of Voters. Each semiannual campaign statement requires its own Form 460, which can be found at [www.fppc.ca.gov](http://www.fppc.ca.gov). You must also file a new Form 410 Statement of Organization with the California Secretary of State if you wish to keep your committee open.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.

The FPPC publishes forms and manuals to facilitate compliance with the provisions of the Act.
