**Warning Letter Re: FPPC No. 11/717; Committee for the Election of Jeffrey Lemasters
Tahir for State Assembly 2010; Jeffrey Lemasters Tahir, Respondent(s)**

Dear Mr. Tahir:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),¹ found in Government Code section 81000, et seq. This letter is in response to a referral from the Office of the Secretary of State that alleged you have failed to file campaign statements.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that your committee has failed to file a semi-annual campaign statement for the period July 1, 2010 through December 31, 2010 and a semi-annual campaign statement for the period January 1, 2011 through June 30, 2011.

The Act requires that candidates and committees file campaign statements at periodic intervals. Specifically, the Act provides that with regard to semi-annual statements, committees shall file on July 31 and January 31 of each year reporting activity for the prior six-month period. (Gov. Code § 84200.) Additionally, the Act requires that state candidates who are defeated at an election must terminate their campaign committee no later than nine months after the election. (Gov. Code § 84214; Regulation 18404.1(b)(1).)

Your actions violated the Act because you failed to file semiannual campaign statements for the period July 1, 2010 through December 31, 2010 by the January 31, 2011 deadline and

January 1, 2011 through June 30, 2011 by the January 31, 2011 deadline and failed to terminate your committee by the March 8, 2011 deadline. Since you were defeated at the election and because your committee had very little activity in 2010, we are closing our file on this matter.

However, you must immediately file your delinquent campaign statements with the Office of the Secretary of State and with your local filing officer and you must terminate your campaign committee.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

While the FPPC is not imposing monetary penalties at this time, you are still responsible for any late filing fees assessed by the Office of the Secretary of State. (Section 91013.)

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
