Warning Letter Re: FPPC No. 12/522; Glenn Wedeen, Respondent

Dear Mr. Wedeen:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),¹ found in Government Code section 81000, et seq. This letter is in response to a referral from the Commission's Technical Assistance Division that alleged you failed to file your Annual Statement of Economic Interests. The Act requires persons designated in their agency's conflict of interest code to file a Statement of Economic Interests (Form 700) when they assume office, annually thereafter, and within 30 days of leaving their position.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that as a member of the State of California's Registered Nursing Board, you failed to file your Annual Statement of Economic Interests by the April 1, 2012 deadline. You did, however, file that statement on August 8, 2012 prior to contact by the Commission's Enforcement Division.

Your failure to timely file the required statement is a violation of the Act. (Gov. Code § 87300.) This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation. While the Enforcement Division is not imposing an administrative penalty for this violation, you are still

responsible for any late filing fees assessed by your filing officer, the Commission's Technical Assistance Division.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
