Warning Letter Re: FPPC No. 10/203, Vallejo Firefighters Local 1186

Dear Vallejo Firefighters Local 1186 and Mr. Boothe:

The Fair Political Practices Commission ("FPPC") enforces the provisions of the Political Reform Act ("Act"),¹ found in Government Code section 81000, et seq. This letter is in response to a complaint filed against Vallejo Firefighters Local 1186 by the Secretary of State that alleged Vallejo Firefighters Local 1186 failed to file a semiannual campaign disclosure statement.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that Vallejo Firefighters Local 1186 failed to file a semiannual campaign disclosure statement for 7/1/09 until 12/31/09 with the Secretary of State by the deadline of 01/31/10. Vallejo Firefighters Local 1186 did file a semiannual disclosure statement for this period on 07/26/11, however it was after the 01/31/10 deadline and constitutes a violation of the Act.

The Act requires that candidates and their committees file campaign statements at periodic intervals. Specifically the Act provides that elected officers, candidates, and committees shall file semiannual statements. (Section 84200.) Vallejo Firefighters Local 1186 is obligated to continue filing campaign statements until the date it officially terminates.

Your action violated the Act because you failed to file your semiannual campaign statement by the filing deadline. However, because you have no prior violations of the Act and you filed with the Secretary of State, we are closing your case with this warning letter. The

information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.


A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.

Although the FPPC is not seeking a penalty in the current matter, you are still responsible for any late filing fees assessed by your filing officer. (Section 91013.) The FPPC publishes forms and manuals to facilitate compliance with the provisions of the Act.
