**Warning Letter Re: FPPC No. 11/651, Orange County Department of Education**

Dear Ms. Hendrick:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),<sup>1</sup> found in Government Code section 81000, et seq. This letter is being sent as a result of an FPPC investigation of the Orange County Department of Education. The FPPC initiated its investigation after receiving a referral from the California Secretary of State. The referral alleged that Orange County Department of Education violated the Act's lobbying reporting provisions.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that Orange County Department of Education violated the Act by failing to file its reports in a timely manner.

Section 86116 of the Act provides that lobbyist employers must file periodic reports. Section 82039.5 of the Act defines a lobbyist employer as an entity that either "[e]mploys one or more lobbyists for economic consideration, other than reimbursement for reasonable travel expenses, for the purpose of influencing legislative or administrative action" or "[c]ontracts for the services of a lobbying firm for economic consideration, other than reimbursement for reasonable travel expense, for the purpose of influencing legislative or administrative action." Section 86117(a) provides that these reports "shall be filed during the month following each calendar quarter."

The above-mentioned reports are filed by submitting a completed Form 635 to the California Secretary of State. Although the required reports have since been filed, the Orange

County Department of Education failed to timely file a Form 635 for the period covering October 1, 2010 through December 31, 2010 and also for the periods covering January 1, 2011 through March 31, 2011; July 1, 2010 through September 30, 2010; and January 1, 2010 through March 31, 2010.

However, your organization complied with its filing requirements soon after being contacted by the Enforcement Division of the FPPC. Specifically, the FPPC contacted the Orange County Department of Education in a letter dated August 24, 2011 and the Orange County Department of Education filed its missing documents on or around August 29, 2011. Although the required report was eventually filed, the Orange County Department of Education has a history of failing to file its reports in a timely manner. For this reason, we are resolving this case with a warning letter.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
