Re: Warning Letter FPPC No. 06/0997; Ashok K. Bhatt, Ash Bhatt for Assembly Committee

Dear Mr. Mehta:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),¹ found in Government Code section 81000, et seq. This letter is in response to a complaint filed against Ash Bhatt for Assembly Committee alleging it failed to file campaign statements disclosing the disposition of the \$19,101 of cash on hand reported on the last campaign statement filed for this committee.

The FPPC has completed its investigation of the facts in this case. Specifically, we found that semi-annual statements were required for the periods ending December 31, 2005, and June 30, 2006, and that \$36 was the ending cash balance for the Semi-annual Statement filed for the period ending June 30, 2005.

The Act provides in Section 84211, subdivision (e) that a committee report the cash balance at the beginning and end of the period covered by the campaign statement. Section 84200 requires a committee to file semi-annual statements each year no later than July 31 for the period ending June 30 and January 31 for the period ending December 31. And, Section 84214 and Regulation 18404 requires a committee to file campaign statements to the time of termination.

The regulations of the Fair Political Practices Commission are contained in sections 18109 through 18997 of Title 2 of the California Code of Regulations. All regulatory references are to Title 2, Division 6 of the California Code of Regulations, unless otherwise indicated.

Your actions violated the Act because the above mentioned semi-annual statements were not filed and the ending cash balance for Ash Bhatt for Assembly Committee was misreported as \$19,101 on the Semi-annual Statement filed for the period ending June 30, 2005.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
