Warning Letter Re: FPPC No. 12/654; Perez-Allen for Assembly 2012; Kevin Perez-Allen and Adam Steinbaugh, Respondents

Dear Messrs. Perez-Allen and Steinbaugh:

The Fair Political Practices Commission (the "FPPC") enforces the provisions of the Political Reform Act (the "Act"),¹ found in Government Code section 81000, et seq. This letter is in response to a referral from the Los Angeles County Registrar-Recorder that alleged you have failed to file a campaign statement.

The FPPC has completed its investigation of the facts in this case. Specifically, the FPPC found that you failed to file your semi-annual campaign statement for the period January 1, 2012 through June 30, 2012 by the July 31, 2012, deadline with either the Los Angeles County Registrar-Recorder, or with the Office of the Secretary of State.

The Act requires that candidates and their committees file campaign statements at periodic intervals. Specifically, the Act provides that candidates and their committees shall file semi-annual statements on July 31 and January 31 of each year. (Gov. Code § 84200.) You must continue to file campaign statements until such time as you terminate your committee by

filing a campaign disclosure statement as a termination statement and by filing a Form 410, the Statement of Organization, as a termination statement.

Your actions violated the Act because you failed to file a semi-annual campaign statement for the period January 1, 2012 through June 30, 2012, by the July 31, 2012 deadline. Since it appears your committee received very little funding, and since you did not appear on the June 2012 ballot, we are closing our file on this matter.

You must immediately file your delinquent campaign statement with the Office of the Secretary of State and with the Los Angeles County Registrar-Recorder. You may want to consider terminating your campaign committee at this time as well.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC's website ten (10) days from the date of this letter.
