RE: **Warning Letter**  
FPPC Case No. 11/792; Frank Lopez

Dear Mr. Lopez:

The Fair Political Practices Commission (FPPC) enforces the provisions of the Political Reform Act (the Act)<sup>1</sup> found in Government Code section 81000, and following. The Enforcement Division opened a pro-active case against you, investigating whether you failed to disclose a source of income on your Annual Statements of Economic Interests (SEI).

The FPPC has completed its investigation of the facts of this case. Specifically, the FPPC found that you failed to disclose gambling winnings as a source of income on your 2006, 2007, 2008 and 2009 Annual SEIs, from Valley View Casino.

Section 82030, subdivision (a), defines income, in part, as "a payment received," including a source doing business in the jurisdiction or planning to do business in the jurisdiction. Section 87203 requires that those who are elected to an office specified in Section 87200, including city council members, each year must file an Annual SEI disclosing income received during the specified reporting period. Section 87202 provides that when income is required to be reported, the SEI must include any source of income aggregating \$500 or more.

You violated the Act because you failed to timely report a source of income on your 2006, 2007, 2008, and 2009 Annual SEIs. However, because you filed an amendment to these Annual SEIs, you cooperated with the Enforcement Division, and you had a good faith belief that the payments did not have to be reported from the Casino, we are closing our file with this warning letter.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Your failure to comply with the provisions of the Act in the

future may result in an enforcement action against you, including monetary penalties of up to \$5,000 for each violation.

A warning letter is an FPPC case resolution without administrative prosecution or fine. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or a hearing before an Administrative Law Judge or the Fair Political Practices Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within 10 days from the date of this letter. Upon this notification, the FPPC will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the FPPC website 10 days from the date of this letter.

The FPPC publishes forms and manuals to facilitate compliance with the provisions of the Act.
