**Re: Warning Letter, Cherryl Liddle and Friends of Cherryl Liddle
FPPC Nos. 06/1077 & 07/130**

Dear Ms. Liddle:

The Fair Political Practices Commission (the "FPPC") enforces provisions of the Political Reform Act (the "Act").¹ The Enforcement Division of the FPPC received referrals from the Los Angeles Registrar-Recorder/County Clerk ("County Clerk") that alleged that you and your controlled recipient committee, Friends of Cherryl Liddle (the "Committee"), failed to file required campaign statements in connection with your 2006 campaign for election to the State Senate. After investigating the allegations, the Enforcement Division has concluded that you and the Committee violated the Act by failing to file the required campaign statements.

However, we have determined to close this case with a formal warning letter based upon your personal circumstances and the following facts: 1) you have voluntarily filed the campaign statement covering the required reporting period to the best of your ability; 2) you have no prior enforcement history with the FPPC; 3) you were a first-time unsuccessful candidate for office; 4) the dollar amount raised and expended by your Committee was minimal; 5) all contributions received and payments made occurred in 2006; and 6) you have terminated your Committee as required.

Although we have decided not to initiate an enforcement action for the violations, you are warned that your failure to properly comply with the Act's reporting and disclosure requirements in the future could result in an enforcement action.
