RE: **Warning Letter**
FPPC Case No. 09/498; Daniel Kass

Dear Mr. Kass:

The Fair Political Practices Commission ("Commission") enforces the provisions of the Political Reform Act (the "Act") found in Government Code Section 81000, and following. The Act requires that committees file campaign statements at periodic intervals. This letter is to inform you that you failed to comply with the campaign reporting requirements in 2006.

Section 82013, subdivision (c), defines one type of committee, commonly referred to as a major donor committee, as any person who makes contributions totaling \$10,000. The Act requires that a major donor committee file a Campaign Disclosure Statement (Form 461) for each six month period that it made contributions. The campaign statement must be filed on January 31 and July 31 of each year. (Section 84200(a).)

The Act also requires that a committee file a Late Contribution Report (LCR), Form 497, disclosing any contributions of \$1,000 or more made to support or oppose a candidate, ballot measure, or state political party, during the "late reporting period," the 16 days prior to the election in which the candidate or measure is on the ballot. The LCR must be filed by the committee within 24 hours of making the contribution and filed at every location that the committee is required to file its regular campaign statements. (Section 84203.)

In reviewing the campaign statements on file with the Office of the Secretary of State, we found that on May 28, 2006, you filed an LCR for a \$10,000 contribution to the Friends of Jim Anderson, but that the contribution was not subsequently reported on your major donor campaign statement filed on July 31, 2006. Additionally, since you made two contributions to Californians for Schwarzenegger 2006 during the "late reporting period," you were required to file an LCR within 24 hours of making each contribution. Accordingly, your failure to accurately complete the major donor campaign disclosure statement and your failure to file two


LCRs was a violation of the Act. To fulfill this filing requirement, you must immediately amend your campaign statement to report the \$10,000 contribution to Friends of Jim Anderson made on May 28, 2006 and must file two LCRs disclosing a contribution on May 25, 2006 of \$7,500 and a contribution on May 29, 2006 of \$5,000, both made to Californians for Schwarzenegger 2006. The amended campaign statement and LCRs must be filed with the Secretary of State, the Registrar-Recorder of Los Angeles County, and the Department of Elections of the City and County of San Francisco.

Although you violated the Act, we are closing this matter with a written warning to you. However, the information in this matter will be retained and may be considered should an enforcement action become necessary based on future conduct or newly discovered information.
