RE: **Warning Letter**
FPPC Case No. 09/492; Panish, Shea & Boyle, LLP

Dear Mr. Panish:

The Fair Political Practices Commission ("Commission") enforces the provisions of the Political Reform Act (the "Act") found in Government Code Section 81000, and following. The Act requires that committees file campaign statements at periodic intervals. This letter is to inform you that Panish, Shea & Boyle, LLP failed to comply with the campaign reporting requirements when it contributed \$12,000 to various candidates in June of 2006.

Section 82013, subdivision (c), defines one type of committee, commonly referred to as a major donor committee, as any person who makes contributions totaling \$10,000. The Act requires that a committee file a Late Contribution Report (LCR), Form 497, disclosing any contributions of \$1,000 or more made to support or oppose a candidate, ballot measure, or state political party, during the "late reporting period," the 16 days prior to the election in which the candidate or measure is on the ballot. The LCR must be filed by the committee within 24 hours of making the contribution and filed at every location that the committee is required to file its regular campaign statements. (Section 84203.)

Our records indicate that on June 2, 2009, Panish, Shea & Boyle, LLP, made the following contributions:

Joe Baca, Jr., for State Senate	\$3,000
Rudy Bermudez for Senate	\$3,000
Friends of Ellen Corbett for Senate	\$3,000
Families of Cindy Montanez	\$3,000

Since Panish, Shea & Boyle, LLP, made contributions during the "late reporting period," it was required to file an LCR within 24 hours of making the contributions. Accordingly, your failure to file the LCR was a violation of the Act. To fulfill your filing requirement, Panish, Shea & Boyle, LLP must immediately file an LCR for the \$12,000 in contributions noted above made on June 2, 2006 with the Secretary of State, the Registrar-Recorder of Los Angeles County, and the Department of Elections of the City and County of San Francisco.

Although you violated the Act, we are closing this matter with a written warning to you. However, the information in this matter will be retained and may be considered should an enforcement action become necessary based on future conduct or newly discovered information.
