



Action to donor within the said 30 days will bring this obligation to conclusive closure. It would have been preferred to have sought out an FPPC formal

Ruling because ambiquous interpretation of liability of price value for Councilman's ticket contrasted to invitee quests tickets but enough cumbersome time

have been extensively utilized on this matter. Its time to move onward and plan to report it section D of Form 700 by end Dec. 2013.
