
Dear Fair Political Practices Commission:

As you know, sponsors of events often take the total cost of the event, divide it by the number of people that were in attendance, and then report that amount for each individual to the Fair Political Practices Commission. This practice, which is rightfully motivated by the law, obviously does not take into account those attendees, such as myself, who do not partake of the generosity offered.
