

My friend Matt Donovan is a principal in Donovan Brothers Golf, a company that manages golf courses. As a gift, he gives me and the people who play golf with me a discount rate of \$40 per round. That amounts to a savings between \$18 and \$53 per player, depending upon when the round is played.

This year, I played 20 rounds on Matt's courses, saving me \$1060. My playing partners saved \$2915. The total gift therefore was \$3,975.

Matt is a close friend. I could never allow him, his company, nor any member of his family to appear before me, and he and his company have been on my conflict list for many years. See Canon 4(d)(6)(f); CCP 170.9(b)(3).
