## Comments

Schedule A-2: The Hy & Charlotte Goode Irrevocable Trust is a family trust that benefits my siblings, children, nephews and niece. Each share is an undivided share of the whole and there is no stated formula for dividing the assets. I have reported the whole value of each security position and the entire gross income of the trust. Since I have two siblings and we have a total of 5 children, theoretically the gross income could be divided by 7. If that were done, my "pro rata share" would be in the range of \$10,001 to \$100,000.

The Goode Revocable Trust is also a family trust. Each share is an undivided share of the whole and there is not stated formula for dividing the assets. I have reported the whole value of each security position and the entire gross income of the trust, which is (or is derived from) community property of my wife and me.

In the column "Include your pro rata share of gross income to entity/trust" each trust has a total income of over \$100,000. I have listed it repeatedly because that is what the form seems to call for me to do. But it should not be regarded as if each individual security generates that much income. I have listed in column 3 those security positions which generate more than \$10,000 per year.

Schedule D: I gave a talk to the Kiwanis Club of Walnut Creek at a restaurant whose address I list. All my communications with the organizers was by e-mail and phone, and their website lists no other address. So I list the only address I know. I believe the club meets there regularly.
