3	(a) Public Meeting Decisions Involving Officials Specified in Section 87200. A public					
4	official in a position specified in Section 87200 and disqualified from a decision relating to an					
5	agenda item noticed for consideration at a public meeting subject to either the Bagley-Keene Act					
6	(Section 11120 et seq.) or the Brown Act (Section 54950 et seq.) must recuse him or herself from					
7	the decision as follows:					
8	(1) Form and Content of Public Identification. The official must publicly identify each					
9	type of financial interest held by the official that gives rise to the conflict of interest (i.e. business					
10	entity, real property, source of income, gift(s) or a personal financial effect).					
11	(A) For each financial interest identified, the official must provide the following, as

- 6 room after the identification required by this regulation is made, and refrain from any
- 7 participation in the decision. The official will not be counted toward achieving a quorum while
- 8 the item is discussed.
- 9 (A) For an agenda item on a consent calendar (uncontested items), the official may
 10 remain in the room during the consent calendar.
- (B) If an official has a personal interest in the agenda item as defined in Regulation
- 12 <u>18704(d)(2)</u> and wishes to speak or appear as a member of the general public, following the
- public identification of the financial interest and recusal the official may leave the dais and speak
- or observe from the area reserved for members of the public.
- 15 (4) Special Rules for Closed Session. The public identification must be made orally
- during the open session before the body goes into closed session and may be limited to a
- declaration that the official's recusal is because of a conflict of interest under Section 87100. The
- declaration will be made part of the official public record. The official must not be present when
- 19 the decision is considered in closed session or knowingly obtain or review a recording or any

1	(1) If an official determines not to act because of a financial interest, the official's
2	determination may be accompanied by an oral or written disclosure of the financial interest.
3	(2) The official's presence will not be counted toward achieving a quorum.
4	(3) During a closed meeting of the agency, a disqualified official must not be present
5	when the decision is considered or knowingly obtain or review a recording or any other
6	nonpublic information regarding the governmental decision.
7	(4) An agency may adopt a local rule requiring the official to step down from the dais or
8	leave the chambers.
9	(c) Confidential Information. Nothing in the provisions of this regulation is intended to
10	cause an agency or public official to make any disclosure that would reveal the confidences of a
11	closed session or any other privileged information as contemplated by law including, but not
12	limited to, the recognized privileges found in Regulation 18740.
