6	system approved by the Commission pursuant to Section 87500.2(c)(3), to ensure the statement:
7	(1) Contains the filer's full name, formal official title or designated position, an email
8	address, and the residential or business street address of the filer. The filing officer shall ensure
9	that the filer's full name and the formal position title are complete and accurate to promote the
10	accuracy and consistency of electronic filing system databases.
11	(2) Has been digitally signed and dated by the filer in compliance with Section 81004,
12	unless the statement is an expanded statement filed for an additional position under Regulation
13	<u>18723.1.</u>
14	(3) Sets forth the System Acceptance Number ("SAN") assigned by the Commission to
15	the approved electronic filing system verifying the Commission's certification of the system
16	under Regulation 18756.
17	(b) The filing officer shall promptly notify the filer if the review of an electronically filed
18	statement of economic interests required by subdivision (a) indicates that the statement is
19	incomplete or incorrect in any material respect.
20	(c) An electronically filed statement of economic interests, filed through the
21	Commission's electronic filing system or an approved electronic filing system, which displays

the electronic filing system's SAN, is an original statement for purposes of the Act. A digital

- signature on a statement filed through the Commission's electronic filing system or an approved
 electronic filing system fulfills the requirement of Section 81004 that the statement be signed
- 3 under the penalty of perjury.
- 4 (d) With respect to an electronically filed statement of economic interests filed through
- 5 the Commission's electronic filing system or an approved electronic filing system, a filing
- 6 official, the agency official who receives statements and forwards those statements under Section
- 7 87500, shall forward an electronic copy of the original statement, which itself is an original
- 8 statement under subdivision (c), to the filing officer through the electronic filing system and
- 9 make and retain an electronic copy of the statement. If the Commission is the filing officer, an
- 10 <u>electronic statement filed through an approved electronic filing system must be forwarded to the</u>
- 11 Commission by means of automated data exchange between the approved electronic system and
