3	(a) Section 84305.5 requires a slate mailer to identify the slate mailer organization
4	or committee sending the slate mailer, and to designate by an asterisk (*) each candidate

6	\$100 or more has been received by the organization or committee (either from the
7	candidate, ballot measure committee, or from any other person "at the behest" of a
8	candidate or ballot measure committee as defined in Regulation 18225.7).
9	(b) To ensure that it is easily legible, the Notice to Voters required by Section
10	84305.5 shall appear with a reasonable degree of color contrast between the background
11	and the statement and must appear on a plain background, not superimposed over an
12	illustration or a patterned background. Examples of a reasonable degree of color contrast
13	that would meet the standard required by Section 84305.5 are when the disclaimer
14	disclosure is printed in black text on a white background or a similar degree of color

16	(c) Slate Mailers in Multiple Languages. The Notice to Voters in a slate mailer
17	shall appear in English. In addition, if all or a significant portion of the slate mailer
18	appears in a language other than English, the Notice to Voters must also appear in that

20	(d) Electronic Slate Mailers. In addition to applying to slate mailers sent by
21	traditional mail, the slate mailer identification and disclaimer disclosure requirements of
22	Section 84305.5 apply to slate mailers distributed electronically.
