

1 Amend 2 Cal. Code Regs. Section 18410 to read:

2 **§ 18410. Statement of Organization.**

3 (a) The Secretary of State shall reject the filing of a Statement of Organization  
4 unless it contains all of the following information:

5 (1) Indication of the “Statement Type,” whether initial, amendment, or  
6 termination and, if the committee has qualified, the date of qualification or, if the  
7 statement is a termination statement, the date the committee terminated.

8 (2) The committee identification number, if the filing is an amended statement.

9 (3) The full name, as required by the Act and Commission regulations, street  
10 address, email address, and telephone number of the committee.

11 (4) The full name, street address, email address, and telephone number of the  
12 treasurer, as well as statements of acknowledgment by the treasurer and any assistant  
13 treasurer, pursuant to Section 84102(d).

14 (5) Indication of the type of committee by completing at least one of the following  
15 sections: controlled committee; primarily formed committee; or general purpose  
16 committee.

17 (6) If the committee is a candidate controlled committee, the full name and office  
18 sought by a candidate, including district number, if applicable.

19 (7) If the committee has qualified, the name and address of the financial  
20 institution where the campaign bank account is located and the account number.

21 (8) If the committee is a noncandidate controlled committee, the name of each  
22 principal officer as set forth in Section 84102(c) and Regulation 18402.1.

1 (9) If the committee is a committee primarily formed to support or oppose  
2 specific candidates or measures in a single election, the name of the candidate or the  
3 number, letter, or full title of the ballot measure, the jurisdiction, and whether the  
4 committee is formed to support or oppose the candidate or measure.

5 (10) If the committee is a general purpose committee, indication of whether the  
6 committee is a city, county, or state committee and a brief description of its activity.

7 (11) If the committee is a sponsored committee, the full name, street address, and  
8 telephone number of each sponsor and the industry group or affiliation of each sponsor as  
9 required in Regulation 18419(b)(2).

10 (12) If the committee (A) submits a proposed state ballot measure to the Attorney  
11 General's Office for title and summary, (B) spends \$100,000 or more on circulation of  
12 petitions for a proposed state ballot measure, or (C) is primarily formed to support or  
13 oppose a proposed state ballot measure that has been submitted to the Attorney General  
14 for title and summary, the committee shall state the identification number assigned by the  
15 Attorney General's Office to the proposed ballot measure and the title of the proposal on  
16 the statement of organization. The Attorney General's identification number and the title  
17 of a proposed measure shall no longer be required on a committee's statement of  
18 organization after any of the following: the measure has failed to qualify for the ballot,  
19 the measure number has been added to the committee's name, or the election in which a  
20 measure qualified for the ballot has been held.

21 (13) Signed verification of the statement, including the date, by the treasurer or  
22 assistant treasurer and controlling officeholder, candidate, or state measure proponent.

1           (b) A committee is not in compliance with the provisions of Section 84101 or  
2 84103 until such time as the Secretary of State accepts for filing a statement of  
3 organization or amendment thereto that provides the information required under  
4 subdivision (a)(1-13).

5           (c) Notwithstanding the above provisions, if the statement of organization filed is  
6 an amendment or termination and the information contained on the previous statements  
7 of organization filed by the committee is correct, the amended statement need only  
8 include the committee name, identification number, and verification along with the  
9 amendment, if an amended statement, or the termination date, if a termination statement.
