During 2021-2022, FPPC Staff invested a considerable amount of time working with the San Luis Obispo District Attorney's Office investigating Charles Grace and his company Grace Environmental Services LLC. This led to the FPPC issuing the first Section 1090 Conflict of Interest, Self Dealing violation.

The District Attorney's investigation continued into conflict of interest, illegal business practices, and more ultimately leading to a settlement on June 12, 2023. The press release link is provided below along with the key settlement documents and civil suit filing. Links to local news articles are also provided.

Change is underway in San Simeon CSD. Within 36 hours of the DA's settlement press release the new San Simeon CSD board majority (post November 2022 elections) relieved Charles Grace of his General Manager duties. His company's water and wastewater operations contract will be ended shortly. This month an interim General Manager was appointed.

Please note that in 2022, the former San Simeon CSD board majority paid over \$200,000 of Grace's legal costs through June 30, 2022, to fight the FPPC and SLO DA. He used an expensive, well-connected LA law firm with hourly rates of \$550 to \$750/hour. The district paid his legal fees despite him admitting doing harm to the San Simeon community. Fortunately the DA looked out for our community in their settlement agreement preventing Grace from attempting to obtain more reimbursement for legal costs associated with his wrongdoing.


