16	to satisfactorily perform the contract. "Responsive bid" means a bid that indicates compliance
17	without material deviation from the requirements of the solicitation and the terms and conditions
18	of the proposed contract.
19	(B) A "labor contract" is a contract or agreement reached through collective bargaining
20	or with a representative group regarding the salary, benefits, or terms and conditions under an
21	employment or retirement policy for employees or retirees, including a project labor agreement
22	entered under Public Contract Code Section 2500.
23	(C) A "personal employment contract" is a contract for employment, including the terms
24	and conditions of employment, between the agency and an agency employee.

2	independent contractor is neither a labor agreement nor personal employment contract.

- 8 (B) The officer knows or has reason to know a proceeding involving a license, permit or
