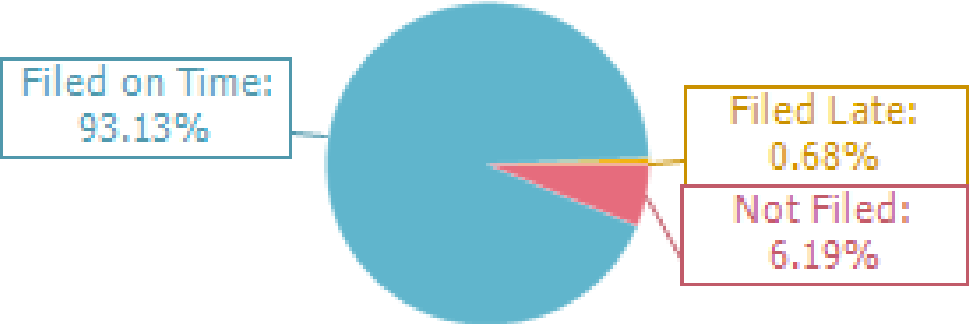

Frequently Asked Questions:

Q: How to reset my password or retrieve my login ID?

A: Go to eDisclosure login page > Click “Forgot Password” or “Forgot Login ID” > Follow steps to reset or retrieve your information.

Q: My position title or agency name is incorrect or has recently changed. Can I edit my position on my next statement?

A: Only FPPC can do this. Please use the “Contact Us” section of eDisclosure and “Report an Issue” to request the change.

Frequently Asked Questions Cont.:

Q: How do I e-file an amendment?

A: Log into your eDisclosure account, click: “Previous Filings” > select the statement you would like to amend > click “Amend” > Click to confirm you want to amend > select the schedule you would like to amend > Submit Amendment.

Q: How do I add another page to a schedule I am currently working on?

A: To add another page to a schedule, click “Add Sheet.”


Electronic Filing Systems

- Some agencies have E-Filing systems, and some do not
- Use either your agencies' FPPC certified electronic filing system or FPPC's electronic filing system to file your Form 700s that are forwarded to the FPPC
- Direct technical questions regarding the FPPC's E-Filing system to Form700@fppc.ca.gov
- Direct technical questions regarding your agency's E-Filing system to your agency's Form 700 filing officials.
