# The Bagley-Keene Open Meeting Act and the Attorney General's "Handy Guide"

The Bagley-Keene Open Meetings Act (Section <u>11120</u>, et seq.) ("Bagley-Keene") sets forth the statutory requirements for state boards and commissions in conducting meetings open to the public. Bagley-Keene requires that "[e]ach state body shall provide a copy of this article to each member of the state body upon his or her appointment to membership or assumption of office." (Section <u>11121.9</u>.) A copy of the Bagley-Keene Open Meeting Act can be accessed through the following link:

The laws set forth under Bagley-Keene are extensive and, in some cases, can be complex. The California Attorney General's Office has drafted "A Handy Guide to the Bagley-Keene Open Meetings Act," which provides useful insight and covers many questions Commissioners might have concerning Bagley-Keene. It is also worth reviewing the Attorney General's guidance given that Bagley-Keene expressly authorizes the Attorney General (along with district attorneys and "any interested party") to take action to stop or prevent violations or threatened violations of Bagley-Keene, or to determine the applicability of Bagley-Keene to past actions or threatened future actions.
