DUTIES AND RESPONSIBILITIES

Analyze and evaluate facts, statements and other evidence obtained from investigations which relate to possible violations of the Political Reform Act (PRA). Formulate and articulate a plan for conducting an effective investigation, including determining what evidence is needed to validate the allegation(s) as well as determine if the evidence supports violation(s) of the PRA.

Locate, contact, and interview individuals who may have knowledge of activities that constitute violations of the Political Reform Act. Use proprietary databases to locate witnesses and obtain evidence pursuant to the investigation, including Accurant, Real Quest, and Lexis-Nexis. Articulate and present to case attorney, Supervising Special Investigator, and Enforcement Chief the results of the interviews as well as the next step in the investigation. Prepare correspondence, case chronologies, spreadsheets of financial and evidentiary data, subpoenas for records and appearance, and clear, concise investigative reports detailing case summations, analyses and evidence received in connection with investigative objectives.

Obtain, analyze and evaluate public documents filed with the Secretary of State, Fair Political Practices Commission and other state and local agencies, including campaign statements, Statements of Economic Interests, marriage records, licenses, and criminal & civil court records. Establish and maintain cooperative relationships with federal, state, local officials and agencies. Serve legal papers, subpoenas and other legal documents. Appear as a witness at civil or administrative proceedings.

SPECIAL REQUIREMENTS

This position may be eligible for telework. The amount of telework is at the discretion of the Department and based on Fair Political Practices Commission's current telework policy. While FPPC supports telework, in-person attendance may be required based on operational needs. Employees are expected to be able to report to their worksite with minimal notification if an urgent need arises, as determined by the FPPC.

Who May Apply: Individuals who have eligibility for appointment to the above class (transfer, list, reinstatement).

How to Apply: Applications will be screened and only the most qualified candidates will be scheduled for an interview.
