6	(ii) The geographical jurisdiction of the newly created agency is the same as the

8	(iii) The member was previously subject to the same disclosure as required for persons

10	(D) The board or commission does not "possess decisionmaking authority" as defined in

12	(3) When to file:
13	(A) Assuming Office Statement of Economic Interests:
14	(i) Every member of a governing board or commission of a newly created agency shall
15	file an assuming office statement within 30 days of assuming office pursuant to Section 87202.
16	(ii) Notwithstanding subdivision (a)(3)(A)(i), a member of a governing board or
17	commission of a newly created agency shall file an assuming office statement not more than 10
18	days after being nominated or appointed to that board or commission as required by Section

(B) Annual Statement of Economic Interests:

Commission on Judicial Appointments or the State Senate.

(i) Every member of a governing board or commission of a newly created agency shall,
no later than April 1 of each year, file an annual statement.

- (C) Leaving Office Statement of Economic Interests:
- 6 Every person who ceases to be a member of a governing board or commission of a newly 7 created agency shall file a leaving office statement within 30 days after leaving office pursuant to 8 Section 87204 or Section 87302, as applicable.
 - (4) Where to file: Pursuant to Section 87500(o) 87500(a)(2)(D)-(E) and Regulation 18730(b)(4), members of governing boards or commissions of newly created agencies, for whom the Fair Political Practices Commission is the filing offer, shall file the statements required under this regulation with their newly created agency or with the agency's code reviewing body, as provided by that code reviewing body the Fair Political Practices Commission using the Commission's electronic filing system. If the Fair Political Practices Commission is not the filing officer of the board or commission of a newly created agency, members shall file the statements required under this section with their newly created agency or with the agency's code reviewing body, as provided by that code reviewing body pursuant to Regulation 18730(b)(4).
 - (5) Effect Upon Initial Statement Required Under Section 87302(b): An assuming office statement or annual statement filed under this section by a member of a governing board or commission of a newly created agency is deemed to satisfy the requirement of Section 87302(b) that an initial statement be filed by that member within 30 days after the effective date of the new conflict of interest code applicable to that member.

- 1 (b) Newly Created Board or Commission of Existing Agency. An individual who is a
- 2 member of a newly created governing board or commission of an existing agency shall file
- 3 statements of economic interests as specified under subdivision (a), as though the individual is a
- 4 member of a governing board or commission of a newly created agency, except that the
- 5 individual's assuming office statement shall be filed pursuant to Section 87302(b).
