

1 Amend 2 Cal. Code Regs., Section 18545 to read:

2 **§ 18545. Contribution Limit and Voluntary Expenditure Ceiling Amounts.**

3 (a) Campaign Contribution Limits

4 (1) For purposes of Section 85301(a), the adjusted contribution limit in effect for  
5 candidates for the Senate or Assembly and candidates for elected seats to the Board of  
6 Administration of the Public Employees Retirement System or the Teachers' Retirement Board,  
7 for an election occurring during the period January 1, ~~2019~~ 2021 through December 31,  
8 ~~2020~~ 2022 is \$~~4,700~~ \$4,900 per person.

9 (2) For purposes of Section 85301(b), the adjusted contribution limit in effect for  
10 candidates for Lieutenant Governor, Secretary of State, Attorney General, Treasurer, Controller,  
11 Superintendent of Public Instruction, Insurance Commissioner and Board of Equalization  
12 members for an election occurring during the period January 1, ~~2019~~ 2021 through December 31,  
13 ~~2020~~ 2022 is \$~~7,800~~ \$8,100 per person.

14 (3) For purposes of Section 85301(c), the adjusted contribution limit in effect for  
15 candidates for Governor for an election occurring during the period January 1, ~~2019~~ 2021  
16 through December 31, ~~2020~~ 2022 is \$~~31,000~~ \$32,400 per person.

17 (4) For purposes of Section 85302(a), the adjusted contribution limit in effect for  
18 candidates for Senate or Assembly and candidates for elected seats to the Board of  
19 Administration of the Public Employees Retirement System or the Teachers' Retirement Board,  
20 for an election occurring during the January 1, ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is  
21 \$~~9,300~~ \$9,700 per small contributor committee.

22 (5) For purposes of Section 85302(b), the adjusted contribution limit in effect for  
23 candidates for Lieutenant Governor, Secretary of State, Attorney General, Treasurer, Controller,

1 Superintendent of Public Instruction, Insurance Commissioner and Board of Equalization  
2 members for an election occurring during the period January 1, ~~2019~~ 2021 through December 31,  
3 ~~2020~~ 2022 is ~~\$15,500~~ \$16,200 per small contributor committee.

4 (6) For purposes of Section 85302(c), the adjusted contribution limit in effect for  
5 candidates for Governor for an election occurring during the period January 1, ~~2019~~ 2021  
6 through December 31, ~~2020~~ 2022 is ~~\$31,000~~ \$32,400 per small contributor committee.

7 (7) For purposes of Section 85303(a), the adjusted annual contribution limit to any  
8 committee, other than a political party committee, in effect for an election occurring during the  
9 period January 1, ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is ~~\$7,800~~ \$8,100 per person.

10 (8) For purposes of Section 85303(b), the adjusted annual contribution limit to any  
11 political party committee in effect for an election occurring during the period January 1,  
12 ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is ~~\$38,800~~ \$40,500 per person.

13 (b) Voluntary Expenditure Ceilings

14 (1) For purposes of Section 85400(a)(1), the adjusted voluntary expenditure ceiling in  
15 effect for Assembly candidates for an election occurring during the period January 1, ~~2019~~ 2021  
16 through December 31, ~~2020~~ 2022 is ~~\$620,000~~ \$649,000 in the primary or special primary  
17 election and ~~\$1,085,000~~ \$1,135,000 in the general or special general election.

18 (2) For purposes of Section 85400(a)(2), the adjusted voluntary expenditure ceiling in  
19 effect for Senate candidates for an election occurring during the period January 1, ~~2019~~ 2021  
20 through December 31, ~~2020~~ 2022 is ~~\$930,000~~ \$973,000 in the primary or special primary  
21 election and ~~\$1,395,000~~ \$1,459,000 in the general or special general election.

22 (3) For purposes of Section 85400(a)(3), the adjusted voluntary expenditure ceiling in  
23 effect for State Board of Equalization candidates for an election occurring during the period

1 January 1, ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is ~~\$1,550,000~~ \$1,621,000 in the primary  
2 election and ~~\$2,326,000~~ \$2,432,000 in the general election.

3 (4) For purposes of Section 85400(a)(4), the adjusted voluntary expenditure ceiling in  
4 effect for a candidate for Lieutenant Governor, Secretary of State, Attorney General, Treasurer,  
5 Controller, Superintendent of Public Instruction, and Insurance Commissioner for an election  
6 occurring during the period January 1, ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is  
7 ~~\$6,201,000~~ \$6,485,000 in the primary election and ~~\$9,302,000~~ \$9,728,000 in the general  
8 election.

9 (5) For purposes of Section 85400(a)(5), the adjusted voluntary expenditure ceiling in  
10 effect for a candidate for Governor for an election occurring during the period January 1,  
11 ~~2019~~ 2021 through December 31, ~~2020~~ 2022 is ~~\$9,302,000~~ \$9,728,000 in the primary election and  
12 ~~\$15,503,000~~ \$16,212,000 in the general election.

13 (c) Officeholder Contribution Limits (per contributor per calendar year)

14 (1) For purposes of Section 85316, the adjusted contribution limit in effect for  
15 officeholders in the Senate or Assembly for calendar year ~~2019~~ 2021 and ~~2020~~ 2022 is  
16 ~~\$3,900~~ \$4,000 per person per calendar year.

17 (2) For purposes of Section 85316, the adjusted contribution limit in effect for  
18 officeholders in statewide elected state offices (other than Governor) for calendar year  
19 ~~2019~~ 2021 and ~~2020~~ 2022 is ~~\$6,400~~ \$6,700 per person per calendar year.

20 (3) For purposes of Section 85316, the adjusted contribution limit in effect for the  
21 officeholder in the Governor's office for calendar year ~~2019~~ 2021 and ~~2020~~ 2022 is  
22 ~~\$25,700~~ \$26,900 per person per calendar year.

23 (d) Officeholder Contribution Limits (aggregate)

1 (1) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit  
2 in effect for officeholders in the Senate or Assembly for calendar years ~~2019~~ 2021 and  
3 ~~2020~~ 2022 is ~~\$64,400~~ \$67,300 per calendar year.

4 (2) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit  
5 in effect for officeholders in statewide elected state offices (other than Governor) for calendar  
6 years ~~2019~~ 2021 and ~~2020~~ 2022 is ~~\$128,700~~ \$134,600 per calendar year.

7 (3) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit  
8 in effect for the officeholder in the Governor's office for calendar years ~~2019~~ 2021 and  
9 ~~2020~~ 2022 is ~~\$257,500~~ \$269,300 per calendar year.

10 (e) The contribution limit and the voluntary expenditure ceiling adjustments shall be  
11 made pursuant to Regulation 18544.

12 (f) The contribution limit and voluntary expenditure ceiling adjustments of this regulation  
13 also will apply to elections held after December 31, ~~2020~~ 2022, until these limits are adjusted by  
14 the Commission for the next biennial period.
